Work starts on Riverlight at Hamilton Reach

Sod turns on latest stage of riverfront project

Brisbane – 12 October 2016 – Work has begun on the next instalment of Frasers Property Australia's spectacular Hamilton Reach waterfront residential development with the official sod turning taking place at Riverlight.

Enriching Frasers Property's already significant offering within the emerging Northshore Hamilton precinct, Riverlight presents a collection of luxury apartments set in lush parkland and offering views to the Brisbane River and Royal Queensland Golf Club.

For the budding chef, a triangulated barbeque space offers three simultaneous groups the chance to use the alfresco cooking space with plenty of hardscaped fixed seating offering private zones to entertain surrounded by landscaped gardens.

An exclusive private dining room is also on offer for Riverlight residents and guests, providing the chance to dine in comfort, or to reserve the space for private functions which is located just moments from the pool and barbeque space.

The Riverlight stage also includes a residents-only Boathouse, offering a chance to explore the Brisbane River and Northshore Beach on kayaks exclusively available for hire by residents.
