

Frasers Property Launches Final Apartment Release at Burwood Brickworks

Frasers Property Australia has announced the launch of The Terrace Collection, the final apartment release for master planned community, Burwood Brickworks.

Launching on 8 May, The Terrace Collection comprises 135 apartments in a variety of one and two bedroom layouts, ranging in size from 50 sqm to 85 sqm, with prices beginning at \$440,000.

The final apartment release follows the immense success of the previous 10 releases, eight of which have sold out in record time, with limited opportunities remaining for the last apartment collection.

Sarah Bloom, General Manager Development Victoria for Frasers Property Australia said they have already seen a lot of interest with over 30% sold prior to release, urging any interested buyers to get in quick.

“These apartments are the social heart and soul of the precinct and resonate with buyers looking to take full advantage of the community aspect, with an impressive collection of shared amenities exclusive to the building.

“The strong interest and results for Burwood Brickworks reinforces the desire for well-considered master planned communities, with convenient amenity and accessibility on their doorstep.”

The sophisticated six level residential design is perched on Foundation Boulevard, the gateway to Burwood Brickworks. Designed by Rothelowman, one of Australia’s most influential and awarded practices, the architecture has been driven by a desire to recapture the grace of homes that represent the golden eras of Melbourne’s built history, drawing on the city’s grand Victorian terraces.

The Terrace Collection features three residential designs, The Courtyard Residences that boast large, lush courtyards and expansive interiors, The Vantage Residences – a limited number of 10 homes overlooking the central Village Green and Dandenong Ranges, and The Gallery Residences featuring a spacious and soothing design with generous outdoor areas and flexible, open plan living

The residences feature a range of first-rate amenities including a modern gym, indoor and outdoor social and entertainment areas complete with a caterer’s kitchen, and a cinema room.

Built on sustainable principles, The Terrace Collection’s commitment to energy saving design means on average, the residences are 14% cheaper to run than a standard apartment, saving up to \$123 per year¹.

Located 19 kilometres from Melbourne’s CBD in the highly sought-after suburb of Burwood East, residents will have access to the world-class Burwood Brickworks shopping centre, an array of social and community amenities, as well as exceptional education and transport options. Spanning 18 hectares, the precinct has been built with sustainability in mind, achieving a 6 Star Green Star Communities rating.

Construction of these apartments is expected to commence in the middle 2021 and the final release of coveted town homes to launch later in the year.
