

Frasers Property wins six of 18 UDIA NSW Awards

Friday's UDIA NSW Crown Group Awards for Excellence was a busy night for Frasers Property Australia, with the company winning six of the 18 awards on offer.

Developed by Frasers Property, the PFD Food Services facility in Chullora won the highly prized Industrial Development category.

The winning projects are now in the running for the UDIA National Awards for Excellence early next year.
